George Hoff the survivor of the dead his Heirs, Executors
and Administrators forever by these presents have given, ex-
changed, sold, aliened, conveyed, and confirmed, and by these
presents do freely, fully, and absolutely give, grant, bargain,
sell, convey, and confirm, unto him the said George Hoff
his Heirs and assigns forever, three lots of Land known &
distinguished by the south West quarter of section eight
Township seventeen of Range Thirteen, also the North East
quarter of section one Township seventeen of Range
Twelve the North West quarter of section one, Township
seventeen of Range Twelve, in the district of Cahaba a
part of Alabama. To have and to hold the said grants
bargains premises with all the appurtenances, privileges
immunities to the same belonging or in any way apper-
taining unto the said George Hoff his Heirs and assigns for
ever and their heirs forever. And I shew

Thomas (Dunn for my self, my Heirs, Executors, and Assigns
do covenant with the said Geo Coffe his Heirs and assigns
that I am lawfully seized in fee of the premises, that they
are free from all incumbrances; that I have good right to sell
and convey the same to the said George Coffe; to hold as aforesaid
and that I will warrant and defend the same to the said Geo
Coffe his Heirs and assigns forever against the lawful claims
and demands of all persons
